I acknowledge the inherent dangers involved in riding on a float, walking in the parade, riding a horse in the parade or riding a vehicle in the parade, including the dangers created by falling off a moving vehicle or horse, or other motor vehicle traffic, street conditions, and other participants.

I understand and agree that no one will be able to hold the above-named parties liable for any injuries to me or my child. This release does not apply to injuries caused directly by the willful misconduct of the Committee, Chamber or the Town.

OFFICIAL PARADE RULES

1. A completed Parade entry registration, with fees paid, prior to participation in the parade.
2. A Parade coordinator will be on duty to ensure an orderly progression of the parade. Coordinator will have the authority to remove any entry causing a delay, violating parade rules, or failing to cooperate.
3. Parade line-up will begin at 8:00 am, Saturday, August 4, 2007, south of Grande Ave. on Pine St. All entries must be in position and ready by 9:45am.
4. All entries must check-in upon arrival with the Parade Coordinator and be directed to their assigned staging area. All entries must keep a representative with the entry at all times within the assigned staging area.
5. The use prior to and/or possession during the parade of any alcoholic beverage, by any entry member, is strictly forbidden.
6. Under no circumstances shall any participant, unit or entry move to a different position within the parade line-up, before or during the parade, except under the direction of the Parade Coordinator. Riding participants will not be permitted to jump off and back on units/entries while the parade is in progress.
7. Participants riding in vehicles or trailers must provide their own vehicles and drivers. Insurance and liability are the sole responsibility of participants.
8. Parade participants are expected to conduct themselves in a courteous manner.
9. Candy may be SAFELY given NEVER THROWN to the parade spectators.
10. Parade entries will be judged and awarded trophies for: *Best use of Theme, Most Unusual, Most Creative, Best Children's Entry, and Judges Choice.*
11. These rules are subject to change on short notice. Advance notice will be given appropriately. Failure to comply with the parade rules will result in entry member or entire entry removal from the parade (even if in progress).
